Sub: Request for reclassification under Regulation 31A of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 along with Rationale for the request and confirmation that the conditions specified in clause (b) of Regulation 31A(3) are satisfied.

I, Rishabh Sunil Surana, ((along with the persons related to him/me together) am writing to formally express my intention to seek reclassification from the status of 'Promoter Shareholder' to the 'Public Shareholder' category, in accordance with Regulation 31A of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ('LODR Regulations').

I, am disclosed as an Individual promoter of Global Education Limited ("GEL/ the Company") in the shareholding pattern filed by the Company with the National Stock Exchange of India Limited (the "Stock Exchange") for the Quarter ended 30<sup>th</sup> June 2025 with Nil shareholding.

Initially, pursuant to the Initial Public Offering (IPO) of 'GEL', I held **36,000** (Thirty-Six Thousand) equity shares of face value **INR 10**/- (Indian Rupees Ten only) each, constituting **1.4499%** of the total issued and paid-up equity share capital of the Company. On 10<sup>th</sup> June 2025 I was holding **2,500** (Two-Thousand Five Hundred) equity shares of face value of **INR 2**/- (Indian Rupees Two only) each representing **0.005%** of the total issued and paid-up equity share capital of the Company.

Subsequently, I have disposed-off the aforesaid equity shares in multiple tranches through open market sale, thereby reducing my shareholding in 'GEL' to [0] "Zero". Post the Transaction, I ceased to hold any equity shares in the Company.

In view of the foregoing, I am making this application under Regulation 31A of the LODR Regulations, seeking reclassification from the status of 'Promoter Shareholder' to the 'Public Shareholder' category of the Company, ("Application"), since I no longer hold any shares, voting rights or control over the affairs of the Company.

## 1. I, Rishabh Sunil Surana (along with the persons related to me together):

- (i) do not collectively hold more than 10% (ten percent) of the total voting rights of the Company;
- (ii) do not exercise control over the affairs of the Company directly or indirectly;
- (iii) do not have any special rights with respect to the Company through formal or informal arrangements including through any shareholder agreements;
- (iv) are not being represented on the board of directors of the Company, or have any nominee directors on the board;
- (v) do not act as key managerial persons in the Company.
- (vi) are not willful defaulter(s)' as per the Reserve Bank of India Guidelines; and
- (vii) are not fugitive economic offenders.
- 2. There is no pending regulatory action against me.
- 3. I, Rishabh Sunil Surana (along with the persons related to me together) shall continue to comply with the conditions mentioned at sub-clauses (i), (ii) and (iii) of clause (b) of Regulation 31A(3) of the LODR Regulations at all times from the date of reclassification failing which, we shall be reclassified as promoter/person belonging to promoter group of the Company.
- 4. I, Rishabh Sunil Surana (along with the persons related to me together): shall comply with the conditions mentioned at sub-clauses (iv) and (v) of clause (b) of Regulation 31A (3) of the LODR Regulations for a period of not less than 3 (three) years from the date of reclassification failing which, we shall be reclassified as promoter/person belonging to promoter group of the Company.

Terms used and not defined herein have the meaning ascribed to them in the LODR Regulations.

Request you to kindly consider and approve my request for reclassification of status from "<u>Promoter Shareholder" to "Public Shareholder"</u> pursuant to Regulation 31A of the SEBI (Listing Obligation and Disclosure Requirements) Regulations, 2015 and arrange to undertake all such actions and prepare and execute all such documentation as maybe necessary for completion of the reclassification.
