It is further stated that the decision is driven by a commitment to secure favorable conditions for both the company and further potential investors and Maintaining transparency and the highest standards of corporate governance is of utmost importance to the company and the decision to withdraw the IPO application is driven by a commitment to uphold these principles and address any concerns that may impact the Company's public image."

Accordingly, the Draft Prospectus has been withdrawn on dated 09<sup>th</sup> January, 2024as informed by the Yola Stays Limited vide letter dated 09<sup>th</sup> January, 2024.
